

### INTRODUCTION

The organization Chaithanya Rural Development Society (R) (CRDS) has completed another fruitful year 2018-19. Started during 1996, at Shimoga, the organization today has extended the services to over 725 villages in two districts, namely Shimoga and Davanagere.

The vision of the organization is to conceive and implement the development programmes that will support the rural poor people for their socio-economic development through awareness, motivation, empowerment of rural women by organizing Self-help Groups (SHGs) training and capacity building activities leading to sustainable management of natural resources. Presently, the organization is based at Shimoga district and it has extended its area of operation in Davanagere and Shimoga, Districts.

During the current year, the organization initiated several new development projects to tackle existing problems such as natural resource management women empowerment, watershed development, sustainable livelihoods, strengthening of CBOs community seed village and capacity building program for ensuring sustainable development programs with community participation.

The NABARD watershed development project for sustainable natural resource development under implementation in 24 villages in Shikaripura, Honnali talukas of Shimoga and Davanagere districts, is benefitting more than 4772 households. The major activities of the project are-soil and water conservation, promotion of dry land horticulture, plantation forestry plants all along the field bunds, drainage line treatments, and income generation activities for landless families, formation and strengthening of Community based organizations etc.

CRDS has carried out all the programs successfully and effectively with an experienced qualified staff's and volunteers. It has developed a good rapport with the community and respective government departments to avail the service for the development of the people.

# NABARD-PROMOTION OF FARMER PRODUCER ORGANISATION (FPOs)

With a focus on the benefit to farming community through pricing and marketing of their produce by establishing their own crop-based farmer producer organization, we have been assigned for promotion and nurturing of four farmer producer organizations in three in Shikaripura Taluka of Shimoga district and one in Honnali Taluka of Davanagere district under NABARD-Producer organization fund.

We have promoted four farmer producer organization, the project aims to improve the productivity of lead crops by adopting appropriate technology, training, the demonstration, collective marketing system at a proper price for their produce and networking farming community for value chain production and marketing with forward and back linkage.



Supporting and providing necessary agriculture inputs and services to the farming community through convergence by establishing their own organization.



Horogoppa Farmer **Producer Organisation** Limited.. Horogoppa (HFPO) has been promoted for collective production and marketing of maize & Paddy crops. 510 farmers from 5 villages have put their share amount of Rs 1000.00 in the organization, 10 members executive committee has been formed and registered under 581(c)-Indian Companies Act 1956 Amended 2013. Farmer mobilization programs, trainings, exposure visits are conducted to mobilize the farmers.

In all FPOs intended to provide the platform for selling and purchase of agriculture produce either as raw or value-added products and marketing of all processed, value-added branded agriculture products by establishing the market network. It is

farmer's Agriculture Producer Organisation is promoted to encourage farming families for scientific cultivation, management and optimum production of agriculture crops like Maize, Paddy Millets, Pulses and Oilseeds under rainfed or irrigated condition.



FPOs basically targeting cultivation, production, processing, grading and value addition to Maize crops cultivated under rainfed condition. FPOs targeting poor and rainfed farming families and provides all training, technical and material inputs for the cultivation of Maize crops even under poor rainfall condition. FPOs provides doorstep services to farming families either to supply or purchase of agriculture goods and inputs at an affordable cost and bearing proper price for their crops.

# INTEGRATED WATERSHED MANAGEMENT PROJECT (IWMP)

Integrated watershed development project is being implemented in four talukas of Shimoga district through District Watershed Development Department, Shimoga. The main objective of IWMP watershed project is to improve the productivity of land through proper conservation and management of soil & water, improving the living standard of poor, landless and other community through various land based and livelihood interventions.

Conducting Grama Sabha, village meetings and PRA in the watershed villages to create awareness and to improve community involvement in watershed development activities.

- Conducting household survey and land use survey for effective implementation of land-based and community development activities.
- Formation of SHG's and watershed development committees in each subwatershed for their participation in watershed development activities.
- Training and capacity building of watershed community through imparting project based & need based training.



- Communication & coordination with taluk watershed and District watershed department officers for timely implementation of watershed activities and payments.
- Updating of watershed records, bills and Preparation of progress reports with department officers and submission to Joint Director of Agriculture, Shimoga

# INSTITUTION DEVELOPMENT PROGRAMS:

In order to promote community-driven programs through community empowerment, CRDS has been formed and established Chaithanya Community Capacity Building Center (CCBC) at Shimoga. Chaithanya - Grama Vikasa functions as capacity building centre for Grass root level various NGO's, Community Based Organisations and farmer groups to help them in improving their technical capacity and knowledge in various community development areas.

Chaithanva is having demonstrative models of Vegetable cultivation, Bee farming, composting techniques, Treebased farming, soil & water conservation measures, **Training** programs Reproductive child Health care, SHG concept, Books & account maintenance, Finance Management Watershed development, Organic farming integrated farming, Tree-based farming, livestock and fodder management activities have been conducted in the training centre. Watershed development project planning, implementation, monitoring and management aspects training's are conducted for the NGO staff.



# Adoption Organic Farming under NHM Scheme:

As required under the scheme, Chaithanya has to facilitate "Group Organic Farming" for conversion of conventional fields/farms to organic. Adoption and certification of Farms. Ensure the necessary technology transfer to farmers.

Ensure necessary documentation and facilitate certification. Chaithanya is also supposed to assist farmers in marketing or Organic produce.

The project will be implemented in Shikaripura Taluka of Shivamogga District selected in Hosuru and Talagunda hoblies has 2 clusters. Each of 50 Ha totally 100 Ha areas.



The Chaithanya have to be performed through some steps to achieve the program, initially motivate farmers groups in selected cluster/s. Develop a team of workers to act as team leader, internal quality manager and field inspectors. Introduce an Internal Control System (ICS) as per the requirement of section V of NPOP. To maintain records of Organic farms.



To enforce **ICS** through internal inspections. To act as technology messenger and to advise farmers on the package of practices, Organic farm management input management maintenance of conformity to NSOP. To facilitate group certification through an accredited certification agency as per the requirement of growers group certification and as per NHM guidelines. Arrange transport processing, and sale organically grown food. Any agency that has already assisted agencies/ farmers for sale of Organic produce will be preferred.

# Rajiv Gandhi Chaithanya Yojane (RGCY):

Karnataka State Rural Livelihoods Mission (KSRLM) has been entrusted with the task of implementing the National Rural Livelihoods Mission in the state of Karnataka. Sanjeevini is the name given to the Karnataka State Rural Livelihood Mission.

Sanjeevini will be implemented in the State through a registered society called the Karnataka State Rural Livelihood Promotion Society.

The mission of the KSRLM is - "To reduce poverty by providing gainful wage and self-employment opportunities through community institutions resulting in

sustainable improvement in their livelihoods and to enhance livelihood opportunities.



Under KSRLM Rajiv Gandhi Chaithanya Yojane is designed by the Ministry of Rural Development and Panchayat Raj to prevent migration of rural youth to urban areas in search of employment. chaithanya will work as project Support Agency for the next three years for this program in Shimoga, Sagara & Hosanagara Talukas of Shimoga district.

# Compressive Horticulture Integrated Development:

The Centrally Sponsored Scheme of National Horticulture Mission (NHM) is being implemented in Karnataka since 2005-06. From April 2014 onwards, NHM has been subsumed under Mission Development offor Integrated Horticulture (MIDH) for holistic growth of the horticulture sector covering fruits, root vegetables. and tuber crops, mushrooms, spices, flowers, aromatic plants and plantation crops

Major activities being undertaken NHM production under distribution of planting material, vegetable production, seed area expansion, reiuvenation of old and senile orchards. the creation of community water protected cultivation, resources, IPM/INM, organic mushroom cultivation, farming, development of post-harvest management & marketing infrastructure and human resource development etc.



The focus crops identified under the programme include Mango, Banana, Pineapple, Cashew, Cocoa, Ginger, Pepper, Flowers and Aromatic plants in Shimoga district.



Major activities being undertaken under NHM are production and distribution of planting material, vegetable



production, expansion, area rejuvenation of old and senile orchards, creation community water protected cultivation, resources, IPM/INM, organic mushroom cultivation, farming, development of post-harvest management & marketing infrastructure and human resource development etc.
